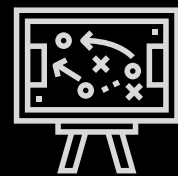

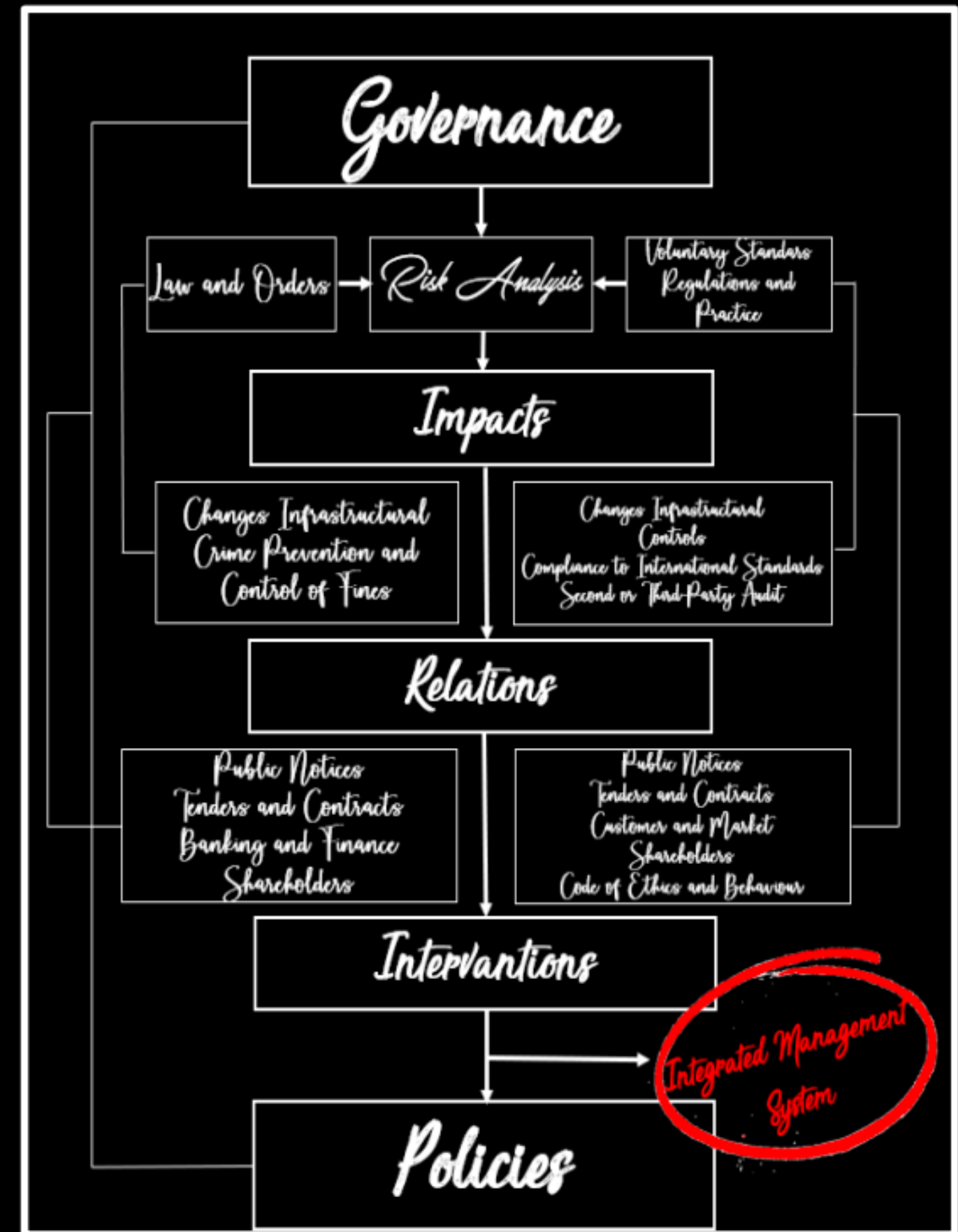

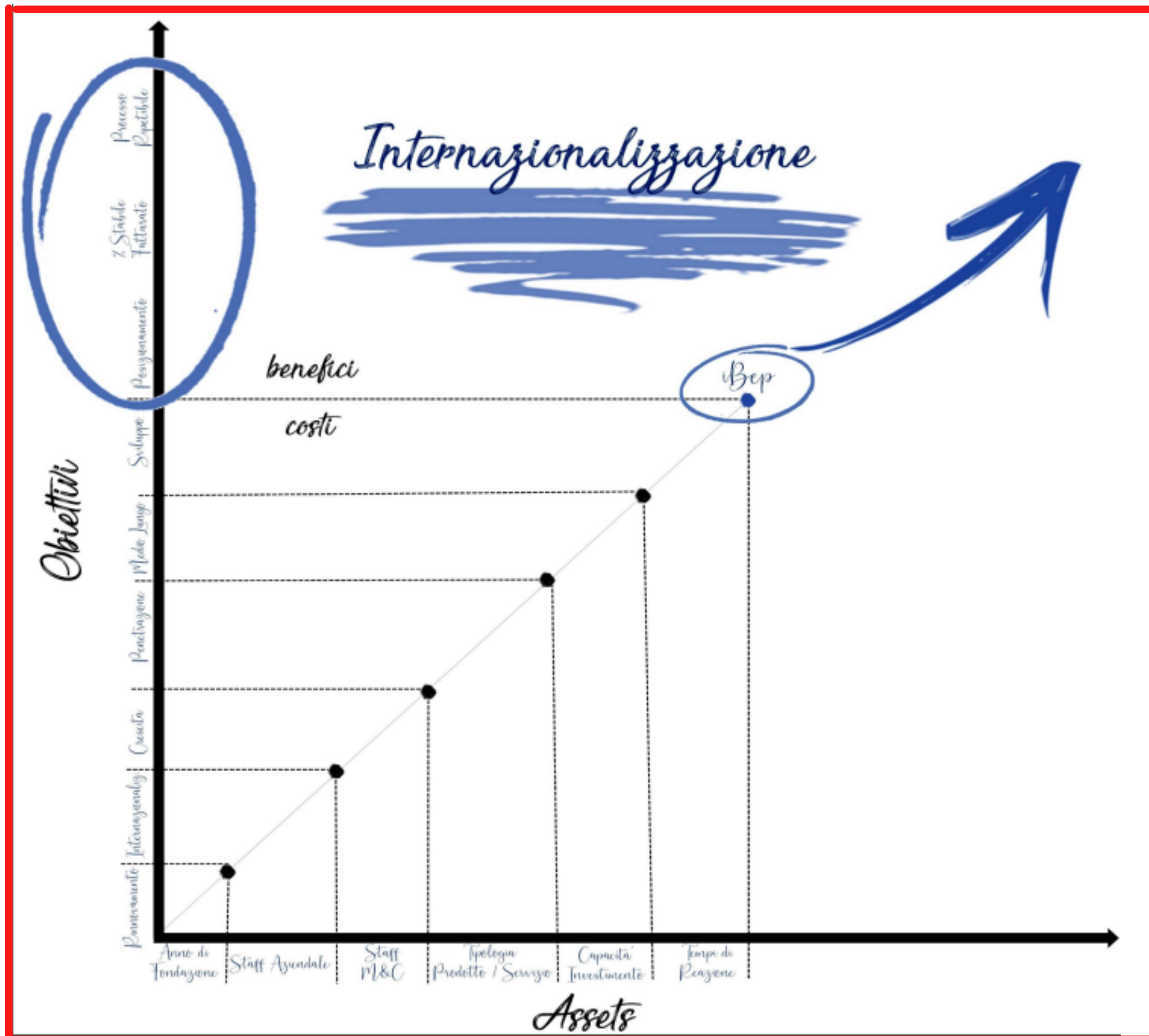
In the current economic context characterized by unpredictable changes of context and by the continuous search for competitive innovation, there are two basic requirements (internal and external):

It also analyzes the internal resources and assets to be improved to achieve the objective, developing the necessary indicators and implementing activities for successful internationalization processes.

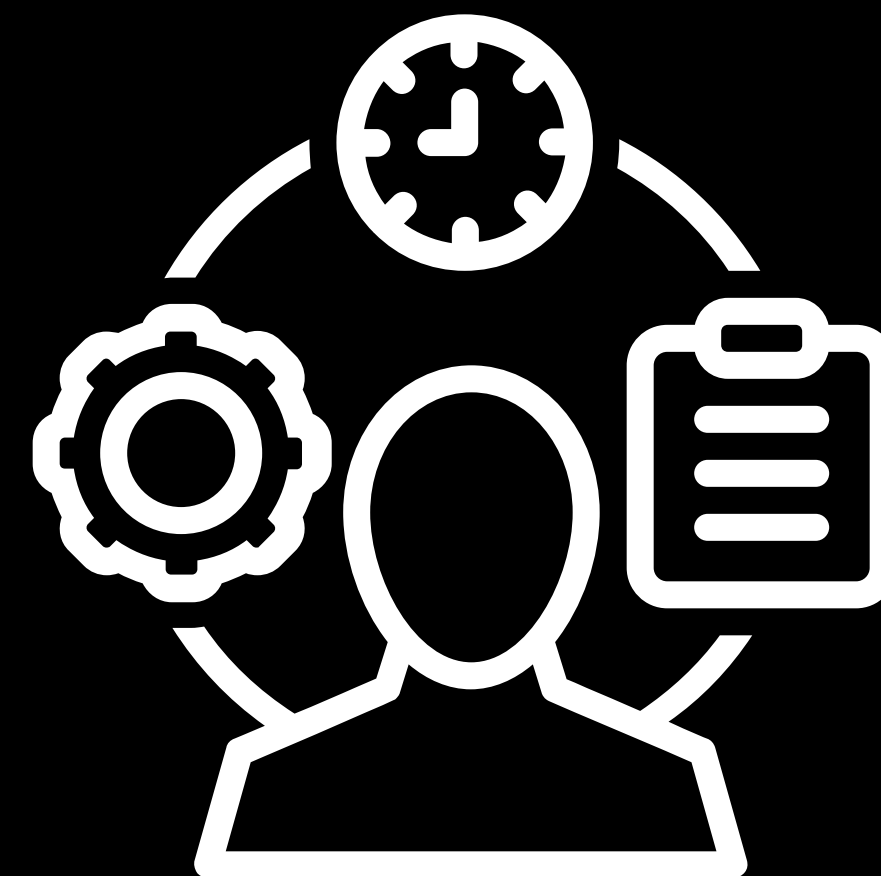
