This is a specialized merchandise clearance service in the airline's warehouses at the airport no need to transfer them to warehouses, it must be carried out within business day after the arrival of the merchandise to the National Customs Territory. To do so, the AWB must be consigned as Descargue Directo, it must have satisfied all the legal and regulatory requirements and all the original supporting documents.
